LEARN ABOUT THE WILY SNAKEHEAD!

Saturday, 2 pm, Feb. 22, Huntley Meadows Park.

The non-native Northern snakehead fish (*Channa argus*) has been seen in Little Hunting Creek and other northern Virginia waterways.

At the next quarterly meeting of the Friends of Dyke Marsh, John Odenkirk, fish biologist with the Virginia Department of Game and Inland Fisheries (DGIF), will explore the world of the snakehead—its characteristics, impacts, and future—and discuss the future and health of the Potomac River fishery.

This program is cosponsored by the Friends of Dyke Marsh, the Northern Virginia Chapter of Trout Unlimited, the Assawoman Fishing Unlimited Club, and the Friends of Little Hunting Creek. WETLAND PARCEL PROTECTED

Last fall, a parcel of land entirely within the Resource Protection Area of Little Hunting Creek that is mostly wetlands was threatened with development by an architect who wanted to build a house on stilts. Friends of Little Hunting Creek rallied to the cause of preservation: 62 Stratford Landing neighbors added their names to a letter of opposition sent to Supervisor Hyland, and 35 neighbors and friends made generous pledges to the Northern Virginia Conservation Trust to buy the parcel and preserve it. Our two week "pledge drive" raised about \$42,000. Thanks to all who pledged or signed the letter—you proved yourselves true friends of the Creek!

Our pledges turned out to be unnecessary. After we wrote our letter, the asking price was dropped and neighbors Emily and Pat Paterson (who live directly across from the parcel) were able to buy it. That's very good news, because Pat and Emily want to preserve it as open space and habitat, not build on it.

We proved that the Friends of Little Hunting Creek have the desire, will, and means to act to preserve open space along the creek, and that we have an able and enthusiastic partner in Peggy Stevens, Executive Director of NVCT.
